Children's HCBS Service Provisions

Home and Community-Based Services (HCBS) are a series of Medicaid-funded services designed to help a child/youth achieve functional success in his/her home and community.

The following table summarizes important provisions of the descriptions of the Home and Community-Based Services (HCBS) that will be Medicaid-reimbursable for children who meet eligibility requirements, as determined by the CANS-NY assessment starting in October 2017.
