

# Call for Presentations for the NY Medicaid Population Health Symposium

Responses due July 17, 2019

**NY Medicaid Population Health Symposium**  
**November 18-19, 2019**  
**Grand Hyatt | New York, NY**

The NYS DSRIP Program set out to transform the Medicaid delivery system across the continuum of care and prepare the system for the transition to value based payment (VBP). Alongside the successes that have been demonstrated in performance results, effective collaborations across organizations and systems of care have been established, and significant progress has been made towards achieving the state's goal of 80-90% of Medicaid managed care payments covered under VBP arrangements.

Attaining even greater system performance and levels of VBP participation state-wide requires that key stakeholders have the opportunity to explore what has worked, as evidenced in demonstrable results; explore promising practices; share lessons learned to date; and delve into key priority areas including:

- Service delivery changes resulting from new collaborations and partnerships
- Successes and challenges of VBP contracting from the Managed Care Organization (MCO) perspective
- Community Based Organization (CBO) roles and value proposition
- Best practices and innovations to address the Social Determinants of Health

The **NY Medicaid Population Health Symposium**, scheduled for November 18-19 in New York City, will provide a forum to do just this. The Symposium will convene up to 800 leaders and stakeholders of NY Medicaid for two days of engaging plenary, breakout, and poster presentations, alongside informal networking. Participants will include partners in the transition to VBP, such as: DSRIP PPS and their network partners, physical and behavioral healthcare providers, MCOs, CBOs addressing the social determinants of health, health homes, state agencies, consumer advocates, and public health officials.

## **Call for Session and Poster Presentations**

This invitation is being extended to high performing entities and partnerships to showcase successes in the three focus areas that follow:

- Delivery system design and population health improvement, including new partner configurations and innovative care delivery strategies resulting in improved individual and population health outcomes
- Movement toward health equity, including cross-sector collaboration and CBO strategies that address Social Determinants of Health and reduce disparities
- Transition to value, including established and developing VBP arrangements; payer-payer and provider-provider collaborations; CBO value proposition and participation; and new payment models for integrated care delivery and other innovative delivery models

Preference will be given to multi-stakeholder presentations that demonstrate VBP in action and include the combined perspectives of payers, providers/networks, and community-based organizations. Proposals including a singular entity perspective may not be considered.

Proposals will be reviewed by a program committee and assessed based on the alignment with the three focus areas listed above and inclusion of representation from multiple perspectives (payers, community-based organizations, IPAs and primary care and behavioral health providers). The numbers of presenters per session may vary depending on the format and design of the session, but up to four presenters are anticipated for each session.

Given a limited number of presentation and poster slots, it is unlikely all proposals will be accepted.
