Children's Mental Health Rehabilitation Services Program Licensure Application

OVERVIEW

The New York State Office of Mental Health (OMH) has released guidance on the licensure process for providers designated to provide Other Licensed Practitioner (OLP) and Community Psychiatric Support and Treatment (CPST) services and for providers interested in pursuing designation for OLP and CPST. These services are part of the new single set of Children and Family Treatment and Support Services (CFTSS) available to children on Medicaid with mental health needs who meet medical necessity.

Effective July 17, 2019, such providers require OMH licensure under a new category called the Children's Mental Health Rehabilitation Services (CMHRS) Program. Under this new licensure category, OLP and CPST must be provided directly by the licensed CMHRS Program. Psychosocial Rehabilitation (PSR), Family Peer Support Service (FPSS) and Youth Peer Support and Training (YPST) may be provided directly by the CMHRS Program or via agreement with another agency who is designated to provide these services.

The application for currently designated provider agencies will be due on October 1st.

APPLICATION

All provider agencies interested in applying for CMHRS Program licensure must follow requirements consistent with other established OMH licensed programs, including requirements regarding:

- Application Process
- Certification (Operating Certificate)
- Organization and Administration
- Individual Rights
- Quality Improvement

Provider agencies currently designated for OLP and CPST must complete an E-Z Prior Approval Review (E-Z PAR) application to receive CMHRS Program licensure and continue the provision of such services by October 1st. The E-Z PAR application is submitted electronically through the Mental Health Provider Data Exchange (MHPD). Prior to submitting the E-Z PAR, agencies must:

- Have a consultation with the local Field Office, including notification to the Field Office of intent to complete an E-Z Par or to request de-designation; and
- Attach a Letter of Support from the Local Government Unit (LGU) prior to submitting the application.

Currently designated OLP/CPST provider agencies must continue to provide services during the application process to avoid any interruption of OLP and CPST service provision for children and families. If a provider agency elects to discontinue the provision of services prior to October 1st and/or

chooses not to apply for CMHRS Program licensure, they must do so via a de-designation process by contacting OMH at OMH-Childrens-Designation@omh.ny.gov.

Provider agencies who are not currently authorized by OMH for the provision of OLP and CPST but who are interested in applying for CMHRS licensure should follow the appropriate next steps according to the below table. OMH will host a forthcoming webinar for providers who are not designated for OLP and CPST and who do not otherwise have an OMH license, but who would like to apply for CMHRS Program licensure by completing a Comprehensive PAR.

TIMELINE

Applications must be submitted by October 1st. A decision on the application is provided to agencies within 30 business days.
