RFA: Primary Prevention Infrastructure

OVERVIEW

On October 15th, the Office of Addiction Services and Supports (OASAS) released a Request for Applications (RFA) for one-time funding to support primary prevention infrastructure development. This funding, made available from the federal American Rescue Plan Act and Coronavirus Response and Relief Supplemental Appropriations Act, includes four separate initiatives as part of a single application to support the delivery of primary prevention services. Providers may apply for any or all of the four initiatives.

The full RFA is available <u>here</u>. Applications are due on November 12th.

New Evidence-Based Practice Start-up Support	Up to \$25,000
Environmental Change Strategy Enhancement	Up to \$25,000
Technology Support	Up to \$10,000
Total Maximum Per Provider	Up to \$70,000

ELIGIBLE APPLICANTS

Eligible applicants are OASAS-funded providers who deliver direct primary prevention services.

INITIATIVES

Evidence-Based Program Training & Materials

Funding may be used for training expenses and the purchase of manuals/materials required for implementation fidelity. Providers must select programs for purchasing/updating from the OASAS Registry of Evidence-Based Programs (here) or the Promising Programs & Practices list (here).

New Evidence-Based Program Start-up Support

Funding may be used to support the start-up costs associated with implementing the delivery of a new evidence-based program by the agency. The new program must be selected from the OASAS Registry of Evidence-Based Programs or the Promising Programs & Practices list (linked above). Start-up costs may include program marketing or other equipment needed to implement the evidence-based program. Funds may not be used to provide incentives for individuals to participate in the program.

Environmental Change Strategy Enhancement

Funds may be used to enhance a current Environmental Change Strategy (ECS) implementation or to begin a new ECS. The provider must demonstrate that they are implementing all three components of the strategy (more detail here); however, the funding does not need to be used across all three components and may be used only for what is required.

Applicants should utilize the Strategic Prevention Framework to identify primary prevention service needs in the community. Applicants are encouraged to plan culturally responsive strategies in health disparate or underserved communities.

Technology Support

Expenses for technology support include purchasing of computers and accessories, laptops, tablets, hotspots, software subscriptions (e.g., Zoom), or other technology equipment. Providers must provide a cost estimate for each item as part of the budget document.

TIMELINE

Proposals must be submitted by November 12th and will be reviewed in the order they are received. Funding will be awarded based on applicant eligibility and full completion of the budget and budget narrative, rather than competitive scoring criteria. Awards are expected to be announced on December 1st.
